Our Newsletter is in a different format this year. We hope you will enjoy it and that it will act as a reminder of the League's many activities.

As you all know in January 2006 the PCT Board took the decision to close all the beds at Fairford Hospital against the wishes of the local communities and despite the magnificent attendance of more than 300 supporters at the Board Meeting and the presentation of a petition of 3,574 signatures urging the retention of medical beds in the hospital.

No new patients were admitted to the hospital from 1st February and now there are no in-patients at all.

The PCT has identified a range of out-patient services to be provided at the Hospital, including consultant appointments previously held at Gloucester, Cheltenham or Swindon. Details are awaited but it is understood that new arrangements will come into being later this year

The League is now in discussion with a not for profit Service Provider about the possibility of a new medical facility known as 'Option 4'. Several landowners in the area have expressed an interest and planners are being consulted. We will provide an update at our AGM .

We are aware that a number of Friends have questioned the need to continue to give donations. As you will see from this newsletter the League provides many community services. The changes to Fairford Hospital will result in an even greater need for these services. Donations through the Hospital are already down and in order to continue, our activities must be funded. We rely entirely on donations and fund raising events to achieve this. The House to House collection is our major fundraiser. The money we collect is not given to the PCT or other local hospitals.

Thus I urge you to be as generous as you can and as you have been in the past.

Home Nursing



For patients of Fairford or Lechlade surgeries who are very ill or prefer to stay in their own homes with close family or friends to care for them, helped by G.P.s and District Nurse, we provide any extra nursing through the **Friends in the Community Home Nursing Scheme**, registered with: The Commission for Social Care Inspection, 1210 Landsowne Court, Brockworth, Gloucester, GL3 4AB



Who does the nursing or caring?

The team consists of experienced nurses, known to many of the patients. Some are mothers wishing to work part-time, some practise full time while others may be approaching retirement. They are able to support the patient and the family and work as a team with G.P.s and other medical services.

Who makes the contact?

The G.P or District Nurse contacts our Nursing Co-ordinator who makes all the arrangements.

Who pays for the nursing?

The Friends

There is no charge to the patient or family. Nurses and carers are paid by the League of Friends at N.H.S. rates.

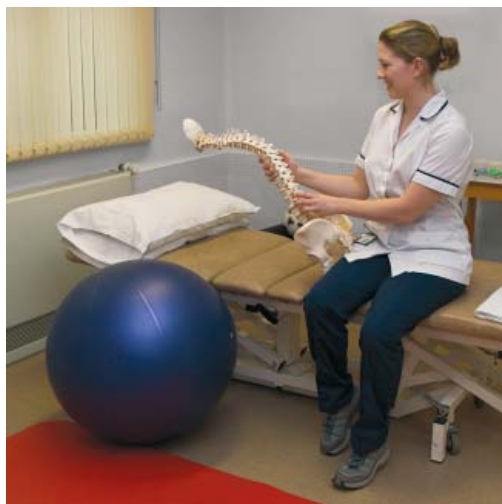

Physiotherapy

The provision of physiotherapy services by the NHS does not always meet the immediate needs of the older members of the community. The League of Friends offers this as a supplement to the already existing care.



Who is covered by the scheme?

Anyone over 60 years of age or chronically sick who is a patient of the Fairford or Lechlade surgeries and whose condition is considered by the Doctor to warrant physiotherapy which is not immediately available through the NHS.

“Option 4”

Under discussion:

A new medical facility for Fairford & Lechlade including:

- * Nursing home beds
- * GP medical beds
- * Out patient services
- * Other local community services

Who does the physiotherapy?

Qualified physiotherapists working under the direction of the Superintendent Physio from the local area and known to many prospective patients. They provide treatment at regular clinics at Fairford surgery or in the homes of those unable to travel.

Who pays for the physiotherapy?

The Friends

There is no charge to the patient or family. The League of Friends has a contract with the PCT for this service.
